Students' application materials will be forwarded to employer partners by the BLG. Employer partners will contact students directly if selected for an interview. If hired, students will become temporary employees of the partner organization for ten weeks during the summer of 2024. Students will also participate in professional and social activities designed to build their legal knowledge and immerse them in life as a lawyer in the dynamic city of Boston.
